2. A consistently good academic record with at least 55% marks (or an equivalent grade in point scale wherever grading system is followed) at Master's degree level.
3. A minimum score as stipulated in API based PBAS set out by the University.
4. The candidate must not have attained the age of 35 years on the closing date of receipt of application. However, relaxation in age limit to SC/ST/BC/MBC/EWS/PwD/Women candidates will be provided as per the policy of Government of Rajasthan issued and amended from time to time.


### **GENERAL TERMS AND CONDITIONS**

1. All the posts of Subject Matter Specialists at KVK are 100% financed by ICAR, New Delhi and appointments on these posts shall coterminous with the Plan/ Scheme, if so by ICAR. If the plan/scheme is abolished then services of the selected person will be immediately discontinued from the University without any notice and without any compensation. He/She will not be adjusted/transferred against any non-plan and/or State plan posts. Selected candidates against these posts should submit a Non-judicial Bond of Rs. 500/- for no claim in this regard before joining.
2. The initial appointments on the post of Subject Matter Specialist, Assistant Professor and Assistant Librarian would be made as Probationer Trainee for a period of two years and the person would be governed by Government of Rajasthan Notification No.F.1 (2)FD/Rules/2006 dated 13.03.2006 & F.12(6) FD/(Rules)/05 dated 13.03.2006; F.14(1) FD/(Rules)/2013 dated 08.06.2015 and No. F.03(22) Agri-3/2018 dated 25.07.2019. Fixed remuneration will be paid to Trainees during period of Probation as per prevailing rules of Government of Rajasthan.
3. As per University Notification No. F.(99)/RAJUVAS/Reg./Gen./2023/794 dated 10.10.2023, at the time of joining the candidate shall furnish a bond on Rs. 500/- stamp within seven working days of joining on the post to serve RAJUVAS for a minimum period of three years, else he/she will deposit an amount of Rupees Five Lakh (Rs. 5.00 Lakh) if he/she leaves RAJUVAS service before the said period.
4. A candidate who is already in regular service in the Central Government/State Governments/PSU/Universities/Board/Local Authority/institutions if selected on any post or if selected in any other post in the same University, may be given the option to get fixed remuneration of the new post or pay of the University/Board/Local Authority/institution, whichever is beneficial, during the period of probation, provided that the pay paid to him/her shall not be more than the pay that he/she would be entitled to draw on the day of joining the new post had he/she joined the new post on the date that he/she joined the old post. After successful completion of probation period his [her pay may be fixed as per rules treating him/her as an existing employee.
5. The award of score for "Research Publications" shall be judged as per NAAS (National Academy of Agricultural Sciences, New Delhi) Score of Scientific Journals 2024 (effective from January 1, 2024).
6. A relaxation of 5% marks shall be provided (from 55% to 50%) at the Master's level for SC/ST/OBC and other category candidates as per prevailing rules of Government of Rajasthan.
7. Reservation shall be provided to SC/ST/OBC and other reserve category's candidates as per Government of Rajasthan reservation policy and Rajasthan Universities Teachers and Officers (Selection for appointment) Act, 1974 (Act No 18 of 1974) only to the bonafide domiciles of Rajasthan State as per Government of Rajasthan directives. The candidates who belong to OBC category must submit their caste certificate issued recently (Not before six months from the date of interview) for the purpose of non-creamy layer. Similarly, the claim of a seat under the EWS category shall also subject to the production of a valid certificate issued by a competent authority of the government of Rajasthan.





8. Reservation and other relaxation for Person with Disability (PwD)) candidates are as per State Government Rules.
9. The horizontal reservation to Divyangjan (Specially Abled)/Person with Disability (PwD) candidates shall be provided as per government of Rajasthan rules as amended from time to time that means the candidate shall be included/adjusted in the same category to which he/she belongs.
10. In case of unavailability of eligible and suitable candidate of Rajasthan from BC/MBC/EWS category, these posts shall be filled as per Government of Rajasthan rules.
11. The reservation to female candidates including widows and divorcee shall be provided as per the reservation policy of the Government of Rajasthan, to the bonafide residents of Rajasthan vide Government of Rajasthan order no. 3 (49) Krishi/Groups-3/2016 dated 17-03-2017.
12. In case of unavailability of eligible and suitable divorcee or widow candidate, these posts shall be filled through interchange among divorcee/widow of the same category. If eligible and suitable divorce/widow candidates are also not available, these posts shall be filled through other women candidates of the same category. Further, in case of unavailability of eligible and suitable women candidate, these posts shall be filled through Male candidate of the same category for which it is reserved.
13. For posts reserved for **Person with Disability (PwD)** at S.No. 1, 2, 11,14 and 18, if a suitable person with benchmark disability will not be available for any posts such posts shall be filled by interchanging among other categories of Person with Disability and even if no suitable person will be available for other categories of Person with Disability also, these pots will be filled with a person, other than a person with disability as per reservation policy of GOR.
14. In the event of non availability of eligible and suitable candidate amongst **Economically Weaker Section**, the posts reserved for EWS category will be filled in accordance with the normal procedure as per the reservation policy of GOR.
15. Widow candidate will have to furnish a certificate of death of her husband form the competent authority, and in case of divorcee, she will have to furnish the proof of divorce decree of competent court along with application form.
16. Any candidate appointed through this advertisement shall be governed by General Provident Fund-SAB linked Pension Scheme for Universities/SABs/PSUs as per rules and regulations of the Government of Rajasthan amended time to time.
17. In case of any inadvertent mistake in the process of selection which may be detected at any stage even after the issue of an appointment letter, the University reserves the right to modify/withdraw/cancel any communication made to the candidates.
